### DIRECTIONS FOR USE

**Peanuts:** apply 1-3 quarts per acre in enough water to cover. Apply in 10-14 day intervals

**Row Crops & Vegetables:** (includes cotton, sweet corn, green beans, leafy vegetables, radishes) apply 1-2 quarts per acre.

### SPRAY RECOMMENDATIONS

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility. Avoid tank mixing with heavy phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions.
